Who Should Attend

The Gang Unit Supervision class is intended for officers who are currently or soon to be assigned as supervisors of gang units.

Although this curriculum is designed for personnel who operate against street gangs, security threat group supervisors will be accepted on a space-available basis.

Registration

There is no registration fee. This class is made possible through funding from the Bureau of Justice Assistance (BJA), Office of Justice Programs, U.S. Department of Justice. Class size is limited to 60 attendees on a first-come, first-served basis.

Performance Measurement—This lesson provides an overview of the purpose and use of performance measurement practices in a gang unit.

Logistics and Security—This lesson discusses the importance of the organizational placement and physical housing of law enforcement gang units.

Suppression Strategies and Tactics—This lesson presents a number of strategies and tactics that can be used to suppress gang activity, specifically from the perspective of a supervisor or commander.
